

## OPTIONS FOR RESEARCHING AN ANCESTOR YOU BELIEVE MAY BE HUGUENOT

### 1) VISIT THE HUGUENOT LIBRARY

The Huguenot Library holds all the Huguenot Society's publications, comprising mainly the 62 volumes of the Quarto Series and the 29 volumes of *Proceedings*, renamed in 2013 the *Huguenot Society Journal*. It also holds pedigrees compiled by the Victorian researcher Henry Wagner, [Family Research files](#) covering particular surnames, a vast collection of printed books and many unique manuscript and archive resources.

The Library has moved, temporarily, to the National Archives in Kew (with UCL Special Collections). If you wish to visit, please contact the Society's Librarian to make an appointment at: [library@huguenotsociety.org.uk](mailto:library@huguenotsociety.org.uk) or by telephone on 020 7679 2046, to discuss the material you wish to see. The Librarian can make a limited search of the surname indexes of the Library's main publications and research files, prior to your finalising the appointment, if you need confirmation that there are occurrences of the name in our published records. **However, these occurrences of a surname may not concern your particular ancestor(s)** and it would be up to you to trace any link.
